Masks, Masks and more Masks

Several members of Crazy Quilters have sewn 300 masks with another 100 in the works. Kathryn Cummings, Minister, Real Estate Broker, Healthcare Worker Advocate, and facilitator in getting these masks delivered for us has been busy delivering masks to area hospital and facilities in need. One third went to St. Anthony's Hospital ER Staff, one third to CHI Franciscan Mission Control Nurses and Doctors (Mission Control oversees all 9 hospitals) and one third went to the Virtual Hospital, which includes hospital doctors and nurses and ICU doctors and nurses from various hospitals.

Dr. Jessica said "We are so grateful for the beautiful masks that you made for our care team. They have been used at the St. Anthony's Hospital ER Department and then Mission Control which cares for all of our patients throughout the South Sound. They were made so perfectly and we are so thankful. Bless you in thinking of us all." Jessica Schlicher MD

Note: Doctor Jessica wrote to Kathryn later to say she had just delivered 100 masks to the hospital and said "you just made 100 people sooooo happy!!! I walked through the hospital with a cart full of masks singing "beer? Popcorn?"? one person said it Was Like Christmas ©"

Doctor Jessica sent a thank you card and photo with the hospital staff in the masks so we could see them in use.

I hope I haven't forgotten anyone who contributed (please forgive if I did)....I would like to thank our Crazy Quilter sewers for helping provide these masks, Janine Walker, Kay Thomas, Peggy Knell, Sharon Meeds, Frances Painter and me for doing the sewing and thanks to Connie Meyer, Janine Walker and Pam Elliott for finding us elastic. You are all wonderful and your efforts were and are very much appreciated.


I just wanted you all to know how much your time and effort making these masks was and is appreciated. Using our talents to help others is what we do and with these masks you made a huge difference.
